On behalf of the State Rehabilitation Council (SRC), I am pleased to present the 2010-2011 Annual Report. This report reflects the efforts of the partnership between State Rehabilitation Council members and Nebraska Vocational Rehabilitation (VR) to offer quality services and advocate for Nebraska's individuals with disabilities.

During this past year, SRC members heard reports & Legislative updates from the Director of VR. Reports were also shared from the Client Assistance Program Director, as well as reports from the Statewide Independent Living Council, Assistive Technology Partnership and the NE Youth Leadership Council. This marked the fourth year the SRC hosted a Senator Luncheon at the State Capitol. It provided an opportunity to share information about VR with the Senators attending.

Other actions supported by the SRC:

- Changed the Individual Plan for Employment (IPE) Booklet. These changes were based on the results of the Consumer Input Survey.
- Evaluated VR's Orientation process. The SRC forwarded these results to VR for consideration in a review of the orientation process.
- Approved a satisfaction survey for clients with unsuccessful closures.
- Evaluated the results of the Oost Closure Survey submitted by the Employer Services Committee in an effort to evaluate VR's role in job placement.
- Presented the Entrepreneur of the Year award to four businessess.
- Recommended VR develop guidelines for working with temporary agencies to address the increased use of temp employment agencies by employers.

I would like to thank my fellow SRC Members for their hard work, input and dedication. Without them, this Council would not exist.

During the past year, members of the Client Services Committee focused on surveying various aspects of the Nebraska Vocational Rehabilitation (VR) Program. The following is a synopsis of the survey results and recommendations to VR.

A selected group of consumers who had completed the Discover the Job that Works for You Work booklet were surveyed by a committee member using the Think Out Loud method. Consumers responded that they found completing the booklet was overwhelming, but they did see value in the results. As a result of the survey, Nebraska VR determined that the tools included in the booklet will be incorporated into a decision point and checklist process currently under development to allow for their use based on the individualized needs of the consumer.

The VR Orientation process was evaluated by the Consumer Survey Work Group. Most consumers responding to the survey could not recall the VR Group Orientation. Consumers reacted more favorably to a one-to-one contact describing VR services. As a result of the responses, Nebraska VR offices will begin redesigning their VR Orientation process.

The Client Services Committee developed a series of survey questions focusing on the service satisfaction of VR consumers with an unsuccessful case closure. Easter Seals of Nebraska was contracted to follow up with these consumers and conduct a phone survey to obtain more information on the reasons behind the unsuccessful closure. The surveys are on-going with the results expected in the coming year.

Next year, this Committee will examine potential strategies to assist consumers with independent living-related job retention issues. Selected strategies will hopefully be included as part of the Career Planning activities offered by VR staff.

October was National Disability Employment Awareness Month. The SRC supported the efforts of the VR Marketing team to have all the offices across the state do a coordinated marketing campaign to promote the hiring of people with disabilities and the services VR has to assist businesses with their employment needs. This coordinated effort included press releases and success story videos. The Employer Services Committee also made marketing suggestions to expand VR reach by looking into promotion through speakers' bureaus, business journals, collegiate organizations, civic organizations, and community centers.

In February the SRC held its annual luncheon for Senators. The luncheon educated the attendees about the services offered by VR and the positive impact VR is having on the citizens of Nebraska.

Jason is a Community Health Educator with Nebraska's Department of Health and Human Services. He is the Chairperson of the SRC's Employer Services Committee.

In July the SRC celebrated the Entrepreneurs of Distinction in the state of Nebraska. The award was given to four self-employed individuals that have worked with VR and the Abilities Fund to become self-employed. The four criteria for the award were profitability, contribution to the community, innovation of ideas and hiring/expansion. Governor Dave Heineman presented the awards to the recipients at a reception held in July. Statewide media exposure was given to the event. The Entrepreneurs of Distinction award will continue to be awarded annually by the SRC.

The SRC supported VR's efforts to expand services to minority individuals with disabilities, minority businesses, and temporary employment agencies. The SRC Employment Committee developed guidelines for VR staff to use when they are working with temporary employment agencies. In addition, the Committee is looking at how VR can use 503 Compliance as a tool to market to firms that are subject to this compliance. They are considering how VR can target these firms and be a service to them.

# Transition Services Committee

One of the focus areas this year for the Transition Services Committee was how to increase the number of eligible youth applying for VR services. Currently only 40% of eligible youth apply and 37% of students with disabilities move from high school to VR adult programs. The committee looked at promoting transition services for students through the use of technology, for example, posting videos about the transition process on school websites. Partnering with post secondary institutions to determine if students need assistance from VR is another tool to improve transition services.

The committee received results from a transition survey sent to all

Special Education Directors in the state of Nebraska to determine use of VR services. School staff identified the top three most helpful services provided by VR as being testing, career counseling and college planning.

Related to transition services for students was the information shared with the committee about potential revisions to the Rehabilitation Act. In the future, it is likely the Act will be emphasizing work experience and paid employment for students.

The VR offices continue their discussions with each other regarding the transition process and share the strategies used in each office. This group also examined the process now in place to determine if transition services are functioning as they were originally intended.

The Transition Services Committee continues to find ways to help families and students understand the purpose and role of Nebraska VR.

# Message from the VR Director

This last year was *unprecedented* in many ways. Not only did the economy continue to provide a challenge, but our field offices experienced flooding, leaking roofs, mold, and a small fire. Four of our offices are in the process of relocating due to these *unprecedented* events. In the midst of all that turmoil, Nebraska VR had an increase in outcomes of more than 7% for an *unprecedented* second year in

a row! I'm sure the SRC has heard me use the word *unprecedented* an *unprecedented* number of times over the last year.

During the last year, the SRC was instrumental in the development of initiatives to help Nebraska VR reach out to individuals with disabilities who could benefit from our services. They established a pilot to survey individuals for whom VR had an unsuccessful closure to obtain feedback on what might have been done differently. The SRC supported a refinement of transition-focused activities to place more of an emphasis on work experience for students with disabilities. This helped to clarify our role in the schools and the services we provide.

And because there are more people than ever who could benefit from the services of Nebraska VR, the SRC provided input on marketing strategies that could improve our outreach efforts.

One suggestion built off our evolving use of social media. While reviewing a number of choices for the agency's new logo, a Council member suggested we put the top four choices on the Nebraska VR Facebook website and let the "people" vote! What a perfect way to demonstrate the value we as an agency place on consumer input and involvement! The new Nebraska VR logo was the clear choice of the people.

The ongoing partnership with consumers and businesses through the SRC makes VR unique. You might even say it's *unprecedented*!

### Vocational Rehabilitation Client Success Stories



JAKE VAN HORN

Jake Van Horn had worked as a cowboy for much of his adult life. He had numerous accidents related to his work with horses. Jake sought out assistance from Nebraska VR when his injuries forced him to consider other employment options.

Jake's goal was to start a saddlery business and be self-employed. He worked with staff from Nebraska VR to make this goal a reality. A business consultant with the Abilities Fund was brought in to help Jake develop a business plan.

Van Horn Saddlery opened in May of 2009. The business grew to the point that an Ogallala storefront was opened in May of 2011. Jake and his wife sell his custom made leather products via their website, on Facebook, and from their store. They take orders from all over the US and other countries.

The Nebraska State Rehabilitation Council (SRC) recognized Jake's business success and contribution to his community by presenting him with a 2011 Entrepreneur of Distinction award.



**CALYNN GOWIN** 

Calynn Gowin was active in sports, theater, and the band while attending Waverly High School. She felt these activities helped her overcome shyness and get involved with other people.

Calynn is a young woman who was born with Asperger's Syndrome. Asperger's is part of the autism spectrum of neurological disorders marked by difficulties in communication and social interaction.

In her final year of high school, Calynn had an opportunity to be part of an onthe-job training program called Project SEARCH. The statewide program is a partnership with Nebraska VR, local business, local schools, NE Commission for the Blind and Visually Impaired, Assistive Technology Partnership, and the Division of Developmental Disabilities (DD services).

Calynn trained at St. Elizabeth Regional Medical Center in several different areas of the hospital. She found the job as a Linen Tech to be a great fit. After graduation she accepted a full time position, with benefits, at the medical center.



RYAN WOLF

One minute Ryan Wolf and his younger brother were driving to a store to do some Christmas shopping and the next minute he was fighting for his life. Another car crashed into Ryan's vehicle resulting in devastating injuries. The most significant was a brain injury. After his body healed Ryan still had ongoing issues with the effects of the brain injury (e.g. memory retention).

Ryan turned to Omaha West VR staff seeking help with his employment planning. His VR counselor suggested the Career Solutions Program at the Ollie Webb Center. The program was called the Acquired Brain Injury Job Club. The Job Club was funded by a grant by Nebraska VR using federal American Recovery and Reinvestment Act money (ARRA).

It was a turning point for Ryan. The Job Club helped him build his confidence, improve interviewing skills, and see future job opportunities. After completing the Job Club program Ryan was employed at a Target store.
